- Email attachments of the following file types can now be previewed without downloading them: .doc, .docx, .ppt, .pptx, .xls, .xlsx, and .pdf
- The **Console logs** menu item has been moved to the browser controls (was in Access settings).

Email message body text was not displayed when reading a signed email message that was missing an available root certificate. (WEBAPPS-7365)

Opening the Edit response form on the Mail tab before accepting it from Calendar tab was delayed. (WEBAPPS-7395)

Default values for increments for start/end time while creating new event were 30 minutes. The default is now changed to 15 minutes. (WEBAPPS-7419)

Email Sync option settings were updated. (WEBAPPS-7457)

Third-party apps protocol schemes are now supported (policy controlled).
