Fixed issues

BlackBerry Access did not honor the Proxy-Authenticate/WWW-Authenticate Kerberos authentication header unless it was "Negotiate" (case-sensitive). (GMAGDAND-9646)

BlackBerry Access version 3.0 for Chromebook did not appear in the Google Play store. (GMAGDAND-9654)

The Google Play Store crashed. (GMAGDAND-9664)

Unable to browse to an external site on Android devices due to the device going direct rather than through the web proxy. (FIRST-17147)

Known issues

Dark mode is sometimes applied when using BlackBerry Access on Android OS 8.1 devices, which do not support dark mode. (GMAGDAND-9624)

Known limitations

When a user re-enters their Kerberos credentials and the cached Kerberos TGT ticket is still valid, the user's credentials are ignored. To improve perceived Kerberos authentication delays, the user should save and use the saved credentials.
