## What's new in BlackBerry Edit

In this release of BlackBerry Edit, the BlackBerry Docs To Go app for iOS and Android devices will be upgraded to BlackBerry Edit, which provides improved functionality for secure document viewing and editing within BlackBerry Dynamics.

With this upgrade, users will continue to have access to all the features that were available in BlackBerry Docs To Go and additional features such as:

- Expanded formatting with support for images, shapes, graphs, and charts
- Tracked changes
- · Support for wireless printing.

Note: The "Allow Printing" option in the App configuration for BlackBerry Edit controls this feature. By default, this setting is set to off.

Conversion of Microsoft Office files to PDF

With this release, BlackBerry Docs To Go will change its appearance, icon, and name to BlackBerry Edit in the Apple App Store for iOS, Google Play for Android, and the BlackBerry UEM enterprise app store:

- · No action is required from users if the Automatic Update feature is enabled on their iOS and Android devices.
- All files that the user stored in BlackBerry Docs To Go before the upgrade are available to the user after the upgrade to BlackBerry Edit.
- Users that have the Automatic Update feature disabled on their iOS and Android devices must initiate the update from the appropriate app store.
- No action is required from administrators on the server side. BlackBerry Enterprise Mobility Suite Collaboration Edition, BlackBerry Enterprise Mobility Suite Application Edition, and BlackBerry Enterprise
  Mobility Suite Content Edition, which include entitlement for BlackBerry Edit, are not affected.

### Ensure that you:

- Notify users in your organization about the upgrade, which includes a change of icon, name, and look of BlackBerry Docs To Go.
- Distribute the User Guide for the BlackBerry Edit app to help users learn how to use BlackBerry Edit.

### **Fixed issues**

#### **Android**

You can open files that contain certain non-standard characters, such as Latin (East European), Latin (West European), and Japanese (Shift JIS). (JI 2674191)

### iOS

You could not open a document in BlackBerry Edit if the document originated from a non-BlackBerry Dynamics app such as Google Drive. (JI 2651670)

### **Known issues**

Issues marked with an asterisk (\*) are new for this release.

#### **Android**

- \* If you open a file, tap the BlackBerry Launcher, select Contacts, tap the BlackBerry Launcher and tap BlackBerry Edit, the file that you were viewing does not display. (JI 2720815)
- \* After you upgrade to BlackBerry Edit 2.0.3, comments that were in documents before the upgrade do not display. (JI 2720071)
- \* BlackBerry Edit does not support non-breaking hyphens, so when you open a file, the spelling of words that use a non-breaking hyphen are changed. For example, "mark-up" changes to "markup." (JI 2718181)
- \* When you open a Microsoft Excel spreadsheet that was attached to an email, you cannot use a drop-down list filter to edit the spreadsheet. (JI 2683517)
- \* If you open a document that was attached to a BlackBerry Work email message, edit the document and click Save, the document does not display in the My Documents list. (JI 2671536)

Workaround: Tap Storage to refresh the list.

When you are editing a file, Android icons, such as the navigation buttons, are difficult to see. (JI 2656216)

When the "Allow Printing" policy is enabled, users can save documents as PDF files and print documents as PDF files outside of BlackBerry Edit. For example, users can save PDF files on their device or to Google Drive. By default this policy is disabled. (JI 2648674, JI 2647977)

**Workaround**: In the BlackBerry UEM console, disable the "Allow Printing" policy in the App configuration for BlackBerry Edit.

For documents created in BlackBerry Edit, some underlined text might not display as underlined and spacing between text might not display correctly in a .docx file when you view the file in Microsoft Word. (JI 2646600)

For documents created in BlackBerry Edit, a zero (0) after the decimal point in section numbers does not display in a .docx file if you view the file in Microsoft Word. For example, section 1.03 displays as section 1.3. (JI 2646598)

For documents created in BlackBerry Edit, footers and referenced superscripts do not display in a .docx file if you view the file in Microsoft Word. (JI 2646592)

You cannot select multiple files in BlackBerry Edit and send them as attachments. (JI 2636953)

### iOS

\* BlackBerry Edit does not support non-breaking hyphens, so when you open a file, the spelling of words that use a non-breaking hyphen are changed. For example, "mark-up" changes to "markup." (JI 2718181)

- \* When you open an Microsoft Excel spreadsheet that was attached to an email, you cannot use a dropdown list filter to edit the spreadsheet. (JI 2683517)
- \* You cannot select multiple files in BlackBerry Edit and send them as attachments. (JI 2679400)
- \* BlackBerry Dynamics apps that were built using the BlackBerry Dynamics SDK for Cordova stop responding when they receive files from BlackBerry Edit. (JI 2676184)

If you open a file and tap Open in > Copy to Work > Save to Docs > Local Docs, the file is saved with a number in the file name. Also, if you open a file and tap Open in > Copy to Work > Send Files, the file is attached to the email message with a number in the file name.(JI 2660612)

For documents created in BlackBerry Edit, the section number for headings might not display in a .docx file when you view the file in Microsoft Word. (JI 2646605)

For documents created in BlackBerry Edit, footers and referenced superscripts do not display in a .docx file if you view the file in Microsoft Word. (JI 2646595)

After a user saves a file as a PDF, hyperlinks in the PDF do not work. (JI 2640316)
