Fixed issues

iOS

BlackBerry Edit did not support the hyphen (-) character, so when you opened a file that was sent as an attachment, the spelling of some words might have been changed. For example, "mark-up" changed to "markup." (JI 2718181)

If you opened a file and tapped Open in > Copy to Work > Save to Docs > Local Docs, the file was saved with a number in the file name. Also, if you opened a file and tapped Open in > Copy to Work > Send Files, the file was attached to the email message with a number in the file name.(JI 2660612)

For documents created in BlackBerry Edit, the section number for headings might not have displayed in a .docx file when you viewed the file in Microsoft Word. (JI 2646605)

For documents created in BlackBerry Edit, footers and referenced superscripts did not display in a .docx file if you viewed the file in Microsoft Word. (JI 2646595)

Android

BlackBerry Edit did not support the hyphen (-) character, so when you opened a file that was sent as an attachment, the spelling of some words might have been changed. For example, "mark-up" changed to "markup." (JI 2718181)

If you opened a document that was attached to a BlackBerry Work email message, edited the document and clicked Save, the document did not display in the My Documents list. (JI 2671536)

When you were editing a file, Android icons, such as the navigation buttons, were difficult to see. (JI 2656216)

When the "Allow Printing" policy was enabled, users could save documents as PDF files and print documents as PDF files outside of BlackBerry Edit. For example, users could save PDF files on their device or to Google Drive. (JI 2648674)

For documents created in BlackBerry Edit, some underlined text might not have displayed as underlined and spacing between text might not have displayed correctly in a .docx file when you viewed the file in Microsoft Word. (JI 2646600)

For documents created in BlackBerry Edit, a zero (0) after the decimal point in section numbers did not display in a .docx file if you viewed the file in Microsoft Word. For example, section 1.03 displayed as section 1.3. (JI 2646598)

Known issues

Items marked with an asterisk (*) are new for this release.

iOS

When you open a Microsoft Excel spreadsheet that was attached to an email, you cannot use a drop-down list filter to edit the spreadsheet. (JI 2683517)

You cannot select multiple files in BlackBerry Edit and send them as attachments. (JI 2679400)

After a user saves a file as a PDF, hyperlinks in the PDF do not work. (JI 2640316)

Android

* When a user who is using a device that is running Android 10 (Q), tries to open a file that came in from BlackBerry Work, the following error might display: "Edit does not fully support the version of Android on this device". (JI 2750541)

* When the "Do not allow Android dictation" option in the BlackBerry Dynamics profile in BlackBerry UEM is selected to prevent dictation from keyboards, there are certain keyboards that allow dictation through other channels. (JI 2572324, JI 2742279)

Workaround: To help prevent dictation, select the "Enable Android keyboard restricted mode" option in the BlackBerry Dynamics profile. This applies only to keyboards that support turning of personalized learning.

If you open a file, tap the BlackBerry Launcher, select Contacts, tap the BlackBerry Launcher and tap BlackBerry Edit, the file that you were viewing does not display. (JI 2720815)

When you open a Microsoft Excel spreadsheet that was attached to an email, you cannot use a drop-down list filter to edit the spreadsheet. (JI 2683517)

* You can't select multiple files and send them as attachments in BlackBerry Work.(JI 2636953)
