Fixed issues in BlackBerry Edit 2.3

iOS

You could not easy activate BlackBerry Edit. (JI 2790224)

If you were editing a document and track changes was on, the keyboard might have moved or disappeared. (JI 2780810)

When tracked changes was on in a Microsoft Word document, you could not delete any changes that you made. (JI 2774852)

When you opened a Microsoft Word document, the subsection numbers might not have displayed correctly. (JI 2752101)

For documents created in BlackBerry Edit, footers and referenced superscripts did not display in a .docx file if you viewed the file in Microsoft Word. (JI 2646595)

Android

When tracked changes was on in a Microsoft Word document, you could not delete any changes that you made. (JI 2774852)

For documents created in BlackBerry Edit, footers and referenced superscripts did not display in a .docx file if you viewed the file in Microsoft Word. (JI 2646592)

Known issues

Items marked with an asterisk (*) are new for this release.

iOS

* When you are editing an .xlsx or .xls file in landscape mode, you cannot add or remove a column. (JI 2796198)

Workaround: Edit xlsx or .xls files in portrait mode.

When you open a PowerPoint file in BlackBerry Edit, numbers and font sizes might not display correctly in bar graphs. (JI 2770569)

When you open a Microsoft Excel spreadsheet that was attached to an email, you cannot use a drop-down list filter to edit the spreadsheet. (JI 2683517)

You cannot select multiple files in BlackBerry Edit and send them as attachments. (JI 2679400)

After a user saves a file as a PDF, hyperlinks in the PDF do not work. (JI 2640316)

Android

* When you are editing an .xlsx or .xls file, if you double tap on a merged cell, the data in the cell disappears. (JI 2805075)

When you open a PowerPoint file in BlackBerry Edit, numbers and font sizes might not display correctly in bar graphs. (JI 2770569)

The incorrect slide number displays at the bottom of the slides menu after the last slide is deleted from a .pptx file. (JI 2752587)

When you open a Microsoft Word document, the subsection numbers might not display correctly. (JI 2752101)

When the “Do not allow Android dictation” option in the BlackBerry Dynamics profile in BlackBerry UEM is selected to prevent dictation from keyboards, there are certain keyboards that allow dictation through other channels. (JI 2572324, JI 2742279)

Workaround: To help prevent dictation, select the “Enable Android keyboard restricted mode” option in the BlackBerry Dynamics profile. This applies only to keyboards that support turning of personalized learning.

If you open a file, tap the BlackBerry Launcher, select Contacts, tap the BlackBerry Launcher and tap BlackBerry Edit, the file that you were viewing does not display. (JI 2720815)

When you open a Microsoft Excel spreadsheet that was attached to an email, you cannot use a drop-down list filter to edit the spreadsheet. (JI 2683517)

You can't select multiple files and send them as attachments in BlackBerry Work.(JI 2636953)
