What's new in BlackBerry Edit

Interoperability enhancements: Users can now use BlackBerry Work to edit Microsoft Azure-IP RMS or AD-RMS protected files. This feature requires BlackBerry Work 3.1 or later.

Fixed issues in BlackBerry Edit 3.0

iOS

When you are editing an .xlsx or .xls file in landscape mode, you can add or remove a column. (BBEDIT-560)

When you open a PowerPoint file in BlackBerry Edit, numbers and font sizes display correctly in bar graphs. (BBEDIT-488)

After a user saves a file as a PDF, hyperlinks in the PDF work correctly. (BBEDIT-9)

Android

When you edit an .xlsx or .xls file, if you double tap on a merged cell, the data in the cell does not disappear. (BBEDIT-619)

When you open a PowerPoint file in BlackBerry Edit, numbers and font sizes display correctly in bar graphs. (BBEDIT-488)

If you open a file, tap the BlackBerry Launcher, select Contacts, tap the BlackBerry Launcher and tap BlackBerry Edit, the file that you are viewing displays correctly. (BBEDIT-291)

After a user saves a file as a PDF, hyperlinks in the PDF work correctly. (BBEDIT-9)

Known issues

iOS

When you open a Microsoft Excel spreadsheet that was attached to an email, you cannot use a drop-down list filter to edit the spreadsheet. (BBEDIT-238)

You cannot select multiple files in BlackBerry Edit and send them as attachments. (BBEDIT-56)

When users select multiple files to edit in BlackBerry Edit the files don't open. An error message is not displayed. (G3DOCS-7614)

Workaround: Edit files in BlackBerry Edit one at a time.

Android

* The 'Save as' and 'Save PDF' buttons do not work after you change the device theme from dark to light or from light to dark. (BBEDIT-680)

Workaround: Close and reopen the app.

The incorrect slide number displays at the bottom of the slides menu after the last slide is deleted from a .pptx file. (BBEDIT-427)

When you open a Microsoft Word document, the subsection numbers might not display correctly. (BBEDIT-424)

When you open a Microsoft Excel spreadsheet that was attached to an email, you cannot use a drop-down list filter to edit the spreadsheet. (BBEDIT-238)

You can't select multiple files and send them as attachments in BlackBerry Work. (BBEDIT-56)

When users select multiple files to edit in BlackBerry Edit the files don't open. An error message is not displayed. (G3DOCS-7614)
