Introduction

The BlackBerry Collaboration Service provides an encrypted connection between your organization's instant messaging server and the BlackBerry Enterprise IM app on BlackBerry 10 devices so that users can start and manage instant messaging conversations on their devices. This guide lists the software that is supported by the BlackBerry Collaboration Service.

This guide is intended for administrators who are responsible for installing the BlackBerry Collaboration Service. Before using this guide, an administrator must install and configure BlackBerry UEM. For more information about installing BlackBerry UEM, see the BlackBerry UEM Installation and upgrade content.
