BlackBerry UEM Client version 12.34.0.155244 does not work on Samsung devices running Android 9 and Samsung KNOX 3.3 and there are known issues with version 3.2.1 (KB55102)

## BlackBerry UEM Client version 12.34.0.155244 does not work on Samsung devices running Android 9 and Samsung KNOX 3.3 and there are known issues with version 3.2.1 (KB55102)

#### **Environment**

- BlackBerry UEM versions 12.7 to 12.10
- BlackBerry UEM Client version 12.34.0.155244
- BlackBerry Dynamics SDK
- BlackBerry Connectivity version 1.18.0.790
- Samsung devices running Android 9 and Samsung KNOX 3.2.1 (supported but with known issues)
- Samsung devices running Android 9 and Samsung KNOX 3.3

#### **Summary**

In February 2019, Samsung announced the release of Samsung KNOX version 3.2.1 and 3.3. The new KNOX version is included in the upgrade of the Android OS to Android 9 on Samsung devices. Currently, BlackBerry has found several major issues with Android 9 devices running KNOX 3.2.1 and 3.3 for Samsung KNOX activations. Testing is ongoing.

Users should not upgrade their Samsung devices to Android 9 until BlackBerry and Samsung have corrected these issues.

#### **Impact**

BlackBerry and Samsung are currently investigating several issues. For more information about the issues affecting Samsung KNOX version 3.2.1 and 3.3, visit support.blackberry.com/community to read article 55102.

#### **Additional information**

Although there are still some known issues, Samsung devices running Android 9 and KNOX 3.2.1 are supported for any activation type.

Samsung devices running Android 9 and KNOX 3.3 are supported for non-KNOX activation types such as MDM, Android Enterprise, and User Privacy.

You must update the BlackBerry UEM Client and BlackBerry Connectivity client on these devices to the latest versions:

- BlackBerry UEM Client version 12.34.0.155244
- BlackBerry Connectivity version 1.18.0.790
