# BlackBerry Dynamics support for BlackBerry UEM activation password and QR code

#### **Summary**

The BlackBerry Dynamics SDK 8.0 release has added support for activating BlackBerry Dynamics apps using BlackBerry UEM activation passwords (for example, a password of any length) or QR codes, which simplifies the activation process for users.

- Activating BlackBerry Dynamics apps using a password or QR code is the preferred method of activating apps.
- This feature requires BlackBerry UEM 12.13.
- This feature requires that apps are compiled with BlackBerry Dynamics SDK 8.0 or later.
- The BlackBerry Dynamics SDK will continue to support the 15-character access key.

The Activation Password field now accepts either an activation password or 15-character access key. The legacy 15-character access key is maintained for backwards compatibility with BlackBerry UEM 12.12 and earlier. Ensure that users do not enter hyphens when they enter the 15-character access key.

If an app has been updated to use BlackBerry Dynamics SDK 8.0 and UEM has not yet been updated to version 12.13, the 15-character access key will be required for Dynamics activation. If Dynamics activation is attempted with an activation password or QR code issued from BlackBerry UEM 12.12 or earlier, BlackBerry Dynamics activation will fail.

#### **Impact**

Attempting to use an activation password or QR code generated from BlackBerry UEM 12.12 and earlier will result in a failed BlackBerry Dynamics activation and an error message is displayed to the user.

#### **Resolution - Administrator**

Administrators can generate a BlackBerry Dynamics 15-character access key in the BlackBerry UEM management console if an activation error occurs with an invalid activation password or QR code. For more information about generating access keys, refer to the information in the Administration Guide.

#### **Resolution - User**

Users can generate a BlackBerry Dynamics 15-character access key in BlackBerry UEM Self-Service if an activation error occurs with an invalid activation password or QR code. For more information about generating access keys in BlackBerry UEM Self-Service, refer to the information in BlackBerry UEM Self-Service User Guide.
