A shared calendar cannot be added to BlackBerry Work 2.14.x when UserAgent check is applied. (FIRST-15624)

Meeting invitations are being sent from BlackBerry Work as .ics files to all recipients for GENOA Transformer users. (FIRST-15059)

GENOA Transformer users are experiencing significant mail delays for several days after activating BlackBerry Work. (FIRST-16418)
