Fixed issues

All day events received in GMT+0 are not appearing in Day and Week view. (FIRST-16342)

When using Japanese keyboard to input a location, the first character is not included. (FIRST-16378)

Mountain Standard Time and Arizona Time are incorrectly showing as the same time. (FIRST-16395)

BlackBerry Work version 2.15 crashes with error 'NSException.reason = '-[NSTaggedPointerString substringWithRange:]: Range {1, 18446744073709551615} out of bounds; string length 1' when synchronizing. (FIRST-16448)

BlackBerry Work is crashing for a user when they attempt to setup BlackBerry Work on iOS. (FIRST-16454)

Underscores are being replaced with spaces in the email body of encrypted emails. (FIRST-16359)

Skype meetings cannot be created on iOS devices. (FIRST-16355)

If a recurring event is changed two times, the second change does not synchronize to BlackBerry Work. (FIRST-16549)

Calendar responses from BlackBerry Work cannot be opened in Microsoft Outlook on the organizer's computer when the date and time are set to use a 12 hour clock. (FIRST-16563)

BlackBerry Work crashes when a user is reading calendar events or deleting emails. (FIRST-16652)

Some text is rendered with a different font or size in BlackBerry Work version 2.16 when viewing a .msg attachment. (FIRST-16597)

BlackBerry Work crashes when using iOS 12.1.4. (FIRST-16608)

Users cannot move out of the Subject field using the return key. (FIRST-16736)

A contact that is imported into BlackBerry Work using a .vcf file is synchronized to Microsoft Exchange with a URL encoded value of Phone number '(' and ')'. (FIRST-16704)

The "Download Failure" attachment error message is incorrectly translated in Japanese. (FIRST-16777)

A file extension policy could be bypassed for files without an extension. (G3IOS-21897)

The unread email badge count is not updating after mail has been read or unread from the inbox. (G3IOS-21156)

iPad Pro is showing visible lag when BlackBerry Work for iOS is running in the background. Users must reinstall BlackBerry Work for iOS to resolve the issue.(FIRST-16018)

Known issues

On devices running iOS 13, BlackBerry Work app data is synchronized again after you upgrade to BlackBerry Work 2.19. (G3IOS-22725)
