BlackBerry Work for Android version 3.0.0.1409

This release of BlackBerry Work for Android features the following enhancements:

- **Updated SDK:** The BlackBerry Work app includes a new version of the BlackBerry Dynamics SDK and the CylancePROTECT library.
- **BlackBerry Safe Browsing:** BlackBerry Work checks each URL to determine whether it is malicious or not.
- **Import .ics files:** Users can import .ics files and add them to their calendars.
- **Export .ics files:** Users can export their meetings to .ics files and send them in email messages.
- **Android 6:** BlackBerry Work no longer supports Android 6.
- **Enhanced meeting scheduling:** Users can drag the new event placeholder to adjust the time in the BlackBerry Work calendar based on the availability of participants signaled by color-coded availability indicators.
- **Email and calendar protection:** Users can now protect unprotected email and calendar attachments, Microsoft Office files saved in their Local Docs folder, and Microsoft Office files that they are previewing to a local server. This feature requires BEMS 2.12.5.6 or later.
- **Modern authentication update:** Administrators can now define UPN or SMTP formats for ADAL token generation in modern authentication for the BlackBerry Docs service.
- **Presence service status:** Administrators can now configure the Presence service status to allow users to view the presence status of other users when the environment is configured for on-premises Skype for Business in non-trusted application mode.

Fixed issues

Autodiscover failed if the protocol portion of the Autodiscover URL was the wrong case in the app configuration. (FIRST-17084)

If the name of a zip file contained Chinese characters, the name did not display correctly. (FIRST-17045)

After a user tapped "Reset Application Data" to resynchronize BlackBerry Work with the mail server, a GAL lookup from the Contacts screen did not work. (FIRST-17027)

Calendar events displayed a day early in the daily calendar view. (FIRST-16958)

Some recurring meetings were missing from a shared calendar. (FIRST-16845)

When a user closed the app, BlackBerry Work was sometimes restarted. (G3ANDROID-19884)

When a user was reading an email message in the email list, and a new email message arrived, the screen might have gone blank. (G3ANDROID-19758)

Known issues

The Presence indicator does not update to display the status of online users after a user forces the app to close and then opens it again. (G3ANDROID-20438)

If fingerprint authentication is not configured on a Samsung Note 10 device and fingerprint authentication is enabled in the security policy, BlackBerry Work does not activate. (G3ANDROID-20379)

BlackBerry Work might display a "Website Blocked" message when a user taps on an email that does not contain a URL link. (G3ANDROID-20197)
