## Fixed issues in 6.0.3

Folder permissions on transient connectors now work as expected. (JI 2647095)

## Fixed issues in 6.0.2

Now when you share files without selecting the 'Require recipients to sign in' check box, the recipient is not prompted to log in. (JI 2631889)

## Fixed issues in 6.0.1

Now when you add a second member to a group and click Add, the member is sent to the BlackBerry Workspaces Web Application. (JI 2616665)

You can no longer add a member to a group if the user does not have an email address. (JI 2611947)

When you added a permission to an Active Directory group, the following error message displayed: "An unexpected error has occurred." (JI 2614352)

If a member already existed in a group and then was added to the group again, the user received another notification. (JI 2613422)

# Fixed issues in 6.0.0

When a user had files that were pending read acknowledgment, the files might not have displayed on the Pending acknowledgment page. (JI 2582775)

Searches might have taken a long time to complete. (JI 2571536)


You could not update a user's email address more than once. (JI 2554873)

When a user shared a file and selected the 'Allow access to everyone' permission, the file displayed in search results when it should have been available only through the notification that was sent to eligible users. (JI 2555268)

When the BlackBerry UEM tenant configuration was changed, the BlackBerry Workspaces server continued to use the tokens from the previous BlackBerry UEM tenant configuration. (JI 2534430)

When you created a role, you could not type a name that was a number only. For example, you could not name the role '1'. (JI 2532379)

When you were setting permissions, if two users had the same name, there was no way to distinguish between the users. Now users are identified by email address. (JI 2532255)

When you clicked  for a folder, the 'Share folder' option did not display. (JI 2532212)

If you were using a Safari browser you could not change the language on the log in page. (JI 2511679)
