* When an iManage folder is shared with a user, and the user clicks the notification, clicks Go to folder, a request permissions message displays but it should not. (JI 2730515)

* When an iManage folder is shared with a user, and the user clicks the notification, clicks the title of the folder to navigate using breadcrumbs, the folder that displays is empty. (JI 2730514)

* If a user is mentioned in a file in a folder, when they click the notification and request access to the file, an "Unable to send your request" message displays (JI 2727736)

* If a user receives a permission request for a folder, when they click Approve or Deny, nothing happens. (JI 2727732)

* The number of favorite items that displays in the left hand menu might be different than the number of items that you actually marked as favorites. (JI 2727729)

The ability to edit Microsoft Excel .xlsx files that were created in Microsoft Office is disabled. (JI 2623792)

If two users who are using Microsoft Office for mobile are in the same workspace and they save edits on the same file at the same time, the save fails. (JI 2540324)
