# New in this release

**Dropbox folders:** Users can accept invitations to Dropbox folders that have been shared with them. After the user accepts the invitation, the folder is added to the list of folders that they can access.

**Dropbox repository information:** After logging in to Dropbox in Workspaces, a notification about managing the Dropbox repository displays.

**New file editor:** Users use Office Online to edit supported Microsoft Office files on their devices. The new editor provides users with a similar feature rich experience as the previous editor.

**Native library updates:** The BlackBerry Workspaces native libraries have been updated to support a 64-bit architecture.

# Fixed issues in BlackBerry Workspaces for Android 8.1

If you are using the BlackBerry Dynamics version of the Workspaces for Android app with a long email address, the annotations window is no longer cut off when editing an annotation. (JI 2743606)

When you share an iManage file from Workspaces with another user but later revoke the permissions, the other user can request permissions again. (JI 2735015)

You can choose to enable or disable notifications for the iManage repository. (JI 2732301)

# Known issues

When trying to edit a PowerPoint (.pptx) file, the keyboard does not appear.

**Workaround:** To display the keyboard, long-press and select Edit Text.

When a user tries to save a Microsoft Office document and taps Create new folder, a 'Failed to create folder' error displays. (JI 2641364)

**Workaround:** Save the document to an existing folder, then create a new folder and move the document into the new folder.

When a user tries to upload a large file, a 'Connection error' message might display. (JI 2635243)

**Workaround:** Try to upload the file again or use the BlackBerry Workspaces web application to upload the file.
