Fixed issues in BlackBerry Workspaces for Android 9.0

After you disable the "Sync files only over Wi-Fi" setting, the setting is enabled when you sign out and sign in again. (JI 2876812)

When you create a new Microsoft Office document, you cannot edit the document because the keyboard does not appear. (JI 2756577)

Workaround: Create the document on another platform and add it to Workspaces.

When trying to edit a PowerPoint (.pptx) file, the keyboard does not appear. (JI 2743669)

Workaround: To display the keyboard, long-press and select Edit Text.

When a user tries to save a Microsoft Office document and taps Create new folder, a 'Failed to create folder' error displays. (JI 2641364)

Workaround: Save the document to an existing folder, then create a new folder and move the document into the new folder.

When a user tries to upload a large file, a 'Connection error' message might display. (JI 2635243)

Workaround: Try to upload the file again or use the BlackBerry Workspaces web application to upload the file.
