# **Sizing requirements**

The types and numbers of servers required in your environment depends on the number of users and other usage factors. The tables below describe the minimum server specifications that you can expect depending on the number of BlackBerry Workspaces users in your organization. For help determining the ideal deployment sizing and architecture for your organization, contact to your BlackBerry Workspaces account representative.
