\* When viewing a pdf file in single page view, if you change to continuous view, the pdf skips to page one of the file. (JI 2721638)

When sharing to a new group and adding a large number of members, auto-complete might not work. (JI 2664490)

Clicking on push notifications for iManage content might not perform any action. (JI 2650028)

If a group name is too long, some of the characters are truncated. (JI 2616045)

**Workaround:** Use a group name that has fewer characters.

The ability to edit Microsoft Excel .xlsx files that were created in Microsoft Office is disabled. (JI 2615485)

You cannot use a search term that contains fewer than 3 characters. (JI 2550443)
