New in this release

Dropbox support: Users can now connect to a Dropbox account from their BlackBerry Workspaces for iOS app which allows them to protect and share files easily.

Added line annotation tool: Users can now use lines to annotate documents from the Workspaces viewer.

Individual connector workspace owner: Users who have been granted this role can set up transient workspace connections to an individual external repository. This connection type provides more control over who is sharing data outside an organization.

iOS 10 support: BlackBerry Workspaces for iOS does not support iOS 10.

iManage improvements: The following improvements were made to the iManage feature:

- iManage repositories can now be accessed and managed through the BlackBerry Workspaces web application.
- Users can share a file, access files when they are offline, and manage access to files.
- When a user has a file shared with them, a 'Shared with me' folder is created under the workspace name, which contains all the files shared with that user from that workspace.
- When users disconnect from the an iManage repository, the workspace and permissions are removed.
- Matters (Mapped workspaces) have an iManage icon to differentiate them from workspaces.

Fixed issues in BlackBerry Workspaces for iOS 8.0.1

You can now successfully upgrade from BlackBerry Workspaces for iOS 7.0.5 to BlackBerry Workspaces for iOS 8.0.x on an iPad device. (JI 2762927)

When a file is shared via email with a user and the user can open the file. (JI 2734185)

When you click on Settings > New in this version, the information about the new features in the release displays. (JI 2721689)

When viewing a PDF file in single page view, you can change to continuous view and scroll through the file. (JI 2721638)

Known issues

* If a user who is using an iPad Air 11.3, taps a workspace, then taps a file to view it, taps the back arrow to exit the viewer and taps the back arrow again to return to the workspace, nothing happens. (JI 2745571)

When sharing to a new group and adding a large number of members, auto-complete might not work. (JI 2664490)

* You cannot use a signature image created in Microsoft Word to sign a PDF file. (JI 2632140)

If a group name is too long, some of the characters are truncated. (JI 2616045)

Workaround: Use a group name that has fewer characters.

The ability to edit Microsoft Excel .xlsx files that were created in Microsoft Office is disabled. (JI 2615485)
