Fixed issues

Fixed issues in BlackBerry Workspaces for iOS 9.0

There are no fixed issues in this release.

Known issues

* If you are uploading a document in the app, the upload process is interrupted while you create or edit a document using the Office Online editor. (JI 2765885)

On an iPad device, if you zoom in and out when editing a file in the Office Online editor, the screen turns white and appears empty. (JI 2769044)

Workaround: Tap the back button and edit the file again.

When you open a file in the Office Online editor, a blank page appears for several seconds while the document is loading. The document eventually loads successfully. (JI 2767129)

If you are using a custom font on your device, when you try to perform a search or use autocomplete forms (for example, typing in a recipient's email address) in the Workspaces app, you receive no results. (JI 2762965)

When editing a file in the Office Online editor, the Office help menu does not work properly. (JI 2759838)

When you create a new Office document, a blank page appears for several seconds while the Office Online interface is loading. (JI 2758990)

If a user who is using an iPad Air 11.3, taps a workspace, then taps a file to view it, taps the back arrow to exit the viewer and taps the back arrow again to return to the workspace, nothing happens. (JI 2745571)

You cannot use a signature image created in Microsoft Word to sign a PDF file. (JI 2632140)

If a group name is too long, some of the characters are truncated. (JI 2616045)

Workaround: Use a group name that has fewer characters.

The ability to edit Microsoft Excel .xlsx files that were created in Microsoft Office is disabled. (JI 2615485)
