New in this release

Sharing: You can now easily choose to share with a new group or an existing group, or an email domain.

Line annotation tool: Users can use the annotation tool to draw lines, drag lines to a new position, change line ends, adjust colors, and more.

Notifications: When sharing content, you can choose whether or not to send notifications to the recipients.

Locked files: Locked files display in the 'My locked files' menu item.

OS support: BlackBerry Workspaces for Mac now supports macOS 10.15 and no longer supports macOS 10.12.

Fixed issues

Now when you are disconnected from a network and you send a file, when you reconnect to a network the file is sent and the correct displays. (JI 2719313)

Now when a synchronization completes, the synchronization icon stops displaying. (JI 2719305)

Known issues

* When you are synchronizing large environments and the access token is set to 5 minutes in the administration console, if the Mac goes into sleep mode, the session might expire before the synchronization completes. (JI 2768299)

* After you upload a file, the Open in Workspaces viewer option might not display. (JI 2749673)

Workaround: Synchronize the workspace.

* When you are using the line drawing tool, the annotations toolbar might display out of frame. (JI 2746870)

* If you have the sharing window open when you switch to dark mode, the Add members field displays in white. (JI 2741299)
