New in this release

Individual connector workspace owner: Users who have been granted this role can access a transient workspace through office integration. The user will first need to login to the relevant repository from a supported client (BlackBerry Workspaces Web Application, iOS, Android).

Dropbox support: When working with BlackBerry Workspaces in Microsoft Office, users can now access and save files from their Dropbox account.

Send a copy: The user interface for sending a copy has been improved.

Notifications: When sharing content, you can choose whether or not to send notifications to the recipients.

Added line annotation tool: Users can now use the annotation tool to drag lines, change line ends, adjust colors, and more.

Sharing: You can now choose to share with a new group or an existing group.

Digital signatures: BlackBerry Workspaces now supports the display of digital signatures in PDF files. A digital signature is used to authenticate the identity of a user.

Folder synchronization: Users can now synchronize folders and sub-folders using the BlackBerry Workspaces for Windows app. Synchronizing at the folder and sub-folder level allows users to speed up the synchronization process and saves space on their computers.

Fixed issues in BlackBerry Workspaces for Windows version 8.0

When you open a document in Microsoft Word, the spell check and grammar check features are enabled. (JI 2705890)

You can now attach a large file to an email message that is in the Drafts folder. (JI 2655168)

Now when you click on a comment notification, the comment pane opens. (JI 2636944)

If your organization uses Carbon Black, when you are installing the BlackBerry Workspaces for Windows plugin, an error message might display and the installation will not complete. (JI 2630911)

Workaround: In Carbon Black, whitelist the path *workspaces*.

After a non-file owner edits and saves a file, the 'Send a copy' menu option is available even though the user can't send the file. Note that the menu option does not display once the file downloads. (JI 2144611)
